Jerry reported that on April 7th six club members visited the Pitchfork Ranch south of Yerington and met with rangers of the new Walker River State Recreation Area. We got a nice tour of the ranch house and property where there are proposed plans to build a full hook-up RV campground and a more primitive campground with water and restrooms. We have volunteered to help cleanup eight existing horse corrals with shelters, develop some adjacent equestrian campsites, and install some hitching posts. We also volunteered to create a trail on BLM land from the south end of Pitchfork Ranch around private property to connect the trail to the southern portion of the new park which will create a 60 mile trail from north to south. Some members rode the river trail and spent the night at the facility. Visitor Jan Koval from Carson Valley BCH and Lydia expressed interest on behalf of their clubs to partner with us on these endeavors.
